Rules

1. **Overview:** Terrible's Game Day Giveaway (the "Game") begins at participating Terrible's locations in Nevada and Arizona (the "Territory") beginning on September 30, 2024 and ending on April 6, 2025 (the "Promotion Period"). For the purpose of the Game, a day is defined as beginning at 12:00AM local time and ending at 11:59PM local time at each participating Terrible's locations. An Entry Period is defined below in section six (6) (collectively the "Games"). Void where prohibited. By participating in the Game, each entrant (the "Entrant") unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions Terrible Herbst Inc. (the "Sponsor"), which shall be final and binding in all respects. Black Knight Sports and Entertainment LLC dba Vegas Golden Knights is not a sponsor of this promotion. Please direct all promotion-related inquiries to Sponsor.

3. **How to Play:** During the Promotion Period, download the Terrible's Social House App (the "App") on a compatible smartphone or other mobile device. The app can be found in the [App Store](#) or on [Google Play](#) at no additional cost.

Then, there are two (2) ways to earn a Game Entry during each Entry Period,

- 1) **Visit a participating Terrible's location, make a qualifying purchase and scan the app prior to checkout.** During each Entry Period, make a qualifying purchase of a) \$12.00 USD or more in-store or at the fuel dispenser for one (1) Entry or b) \$12.00 USD or more in-store with any Bud Light product within the transaction for twenty-five (25) extra Entries. Then, present your Terrible's Social House Reward Code and/or enter your 10-digit pin number when prompted by a Team Member at the register to record the transaction. Once the transaction has been completed, all qualifying entries will be automatically uploaded into the Promotions Reward tab in the app. In some cases, please allow up to 24-hours for your Game Entries to appear.

2) **Enter without making a qualifying purchase on the app under Deals and Promotions.**

During the Promotion Period, to play without making a purchase, download the free Terrible's Social House App, and follow the links and instructions provided under the Game in Deals and Promotions. Free entries may take up to 24-hours to be reflected in your Entry Period total. Entrants can earn one (1) free entry per Entry Period.

Limit: each Entrant may earn up to one hundred (100) entries per day and a maximum of five-hundred (500) entries per Entry Period regardless of method of entry. Game Entries will reset to zero (0) on each pre-determined Drawing Date. There are twenty-seven (27) pre-determined Entry Period(s) during the Game.

Entrant hereby waives any and all rights to inspect or approve Sponsor's use of the Submission or Entrant's Likeness, or any part or element thereof. Prize winner shall be responsible for all federal, state and/or local income taxes incurred in association with acceptance of the prize. The Released Parties are not responsible for: (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail/text notifications or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/network accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Game; (vii) any injury or damage, whether personal or property, to Entrants or to any person's computer related to or resulting from participating in the Game and/or accepting a Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. - 2) *Force Majeure:* Sponsor reserves the right, without prior notice and at any time, to terminate the Game, in whole or in part, or modify or suspend the Game, or any portion thereof, in any way, if it determines, in its sole discretion, that the Game is impaired or corrupted or that fraud, breach of confidentiality, or technical problems, failures or malfunctions have destroyed or severely undermined the integrity and/or feasibility of the Game. In the event Sponsor is prevented from continuing with the Game as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), then subject to any governmental approval which may be required, Sponsor shall have the right to modify, suspend, or terminate the Game. Only the type and quantity of prizes described in these Official Rules will be awarded. If, due to printing, production, or human errors, or for any reason, more potential winners in any prize category come forward seeking to claim prizes in excess of the number of each type of prize as set forth in these Official Rules, the winners, or remaining winners, as the case may be, of the advertised number of prizes available in the prize category in question may be selected in a random drawing from among all persons making purportedly valid claims for such prize(s) in that prize category. - 4) *Governing Law.* All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Entrant or Sponsor in connection with the Game, shall be governed by and construed in accordance with the internal laws of the State of Nevada without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.
